1 CHMN KATZ: Anybody opposed? 2 (No response.) 3 CHMN KATZ: Condition 22 has passed. 4 Condition 23. 5 MEMBER HAMWAY: I move 23. CHMN KATZ: Is there a second? 6 MEMBER MERCER: 7 Second. CHMN KATZ: All in favor? 8 (A chorus of "ayes.") 9 10 CHMN KATZ: Anybody opposed? 11 (No response.) 12 CHMN KATZ: And just for the benefit of our newest member, Member Mercer, these are all pretty much 13 14 standard conditions that we have repetitively used in 15 certificates. - 2 MEMBER PALMER: Mr. Chairman, just a quick
- 3 question. We are assuming, and this would be to
- 4 Mr. Derstine, but this was mutually agreed upon by the
- 5 applicant and the intervenor?
- 6 MR. DERSTINE: It was, yes, Member Palmer. The
- 7 only change I would suggest making here, Invenergy is the
- 8 parent of the project entity. The application to
- 9 intervene was filed by SunDog Energy Center, LLC.
- 10 So I would suggest making the change here to
- 11 replace Invenergy with the name of the entity that filed
- 12 the application to intervene and the project entity that
- 13 is seeking the --
- 14 CHMN KATZ: Before we take a vote, why don't you
- 15 go ahead and do that.
- 16 MR. DERSTINE: Okay.
- 17 CHMN KATZ: Because Bert Acken did appear at the
- 18 beginning of the hearing and he indicated that he was
- 19 representing SunDog Energy, and they're the ones that are

- 1 it's a condition, I guess they could -- SunDog could
- 2 indicate that they didn't -- could try to argue that they
- 3 didn't negotiate in good faith.
- But I don't think that that could be -- I mean,
- 5 it could be an issue. It's just like any other condition
- 6 that gets violated --
- 7 MEMBER HAMWAY: Right.
- 8 CHMN KATZ: -- could kick the matter back to the
- 9 Corporation Commission.
- 10 MR. DERSTINE: It would come back to the --
- 11 presumably, and that's I think the issue with these kinds
- 12 of conditions in CECs that require one of the parties to
- 13 go back before the Commission and argue that there's a
- 14 failure to comply with the condition, and then have that
- 15 argument and dispute before the Commission and whatever.
- 16 I don't know what actual remedies or
- 17 jurisdiction the Committee has to -- the Commission has
- 18 to do anything with it. But the condition is what it is,
- 19 and --
- 20 CHMN KATZ: And we're not compelling them to
- 21 reach a agreement. We're just compelling them to
- 22 negotiate.
- 23 MEMBER HAMWAY: I get it. I just think it's
- 24 kind of a waste, but if it helps.
- 25 CHMN KATZ: It doesn't hurt to have that in

- 1 there to satisfy the intervenor.
- 2 MEMBER HAMWAY: That's fine.
- 3 CHMN KATZ: With that change to SunDog Energy
- 4 Center, LLC in Condition 24, do we have a motion to --
- 5 MEMBER PALMER: I will move Condition 24.
- 6 CHMN KATZ: Any second?
- 7 MEMBER MERCER: Second.
- 8 CHMN KATZ: Any discussion?
- 9 MEMBER GRINNELL: Mr. Chairman.
- 10 CHMN KATZ: Yes, sir.
- 11 MEMBER GRINNELL: I was opposed to this
- 12 condition in the first place. And then because
- 13 apparently we did set a precedent on this issue with a
- 14 previous case, and I forget what case.
- But what this does, I don't think we need this
- 16 condition, number one.
- 17 Number two, we are looking at having a meeting
- 18 later on about simplifying this process of these short
- 19 gen-tie projects. But we are injecting conditions that
- 20 may or may not be utilized down the road.
- 21 And I don't believe that we should be an
- 22 arbitrator of how two businesses interact and discuss
- 23 their business.
- We have no financial, we have no jurisdiction,
- 25 actually after rereading some of our responsibilities, to

- 1 be inserting these types of conditions. If two
- 2 businesses can't negotiate a responsible discussion,
- 3 that's between -- that's a civil issue.
- 4 That is not our business. And I am going to
- 5 vote against this based on the fact is we don't belong in
- 6 the real estate business.
- 7 Our job is to evaluate the validity of the
- 8 gen-tie in this case. And I think for us to continue
- 9 inserting this type of a condition on real estate
- 10 negotiations between two businesses -- and I don't even
- 11 know if this Corporation -- I'm not a lawyer, so I don't
- 12 know what kind of power the Corporation Commission has.
- 13 All we're telling people is you all need to
- 14 negotiate a deal. They know they need to negotiate a
- 15 deal. And they don't need us inserting conditions in the
- 16 application. And I'll leave it at that. Thank you.
- 17 CHMN KATZ: Is there any further discussion?
- 18 Mr. Acken, do you have any comment? Because you did
- 19 intervene.
- MR. ACKEN: Thank you, Mr. Chairman. Can you
- 21 hear me?
- 22 CHMN KATZ: Yes.
- MR. ACKEN: Appreciate the opportunity to speak.
- 24 And I understand Member Grinnell's concern to an extent.
- I represent and I have only represented

- 1 applicants before this Committee until this matter. This
- 2 is the first time I've represented an intervenor.
- 3 So I certainly want to be protective of the
- 4 Committee's role and its authority. And here, this
- 5 condition has lawful precedent and it is 100 percent
- 6 consistent with 40-360.06.
- 7 As factor one the Committee shall consider is
- 8 the existing plans for other developments in the vicinity
- 9 of the project. And this Committee can then impose
- 10 conditions to ensure and facilitate compatibility of a
- 11 given project.
- 12 So the SunDog project is an existing plan in the
- 13 vicinity of the project before you. This stipulated
- 14 condition agreed by both parties facilitates the
- 15 environmental compatibility, frankly, of both projects.
- 16 Certainly the one before you. And the SunDog project
- 17 when you see it later.
- 18 So I respectfully disagree that, you know, we're
- 19 asking the Committee to get involved in real estate
- 20 matters. This is simply a good faith, good neighbor, see
- 21 if you can reach a commercially reasonable agreement that
- 22 is good for everyone and is good for the state in order
- 23 to make sure we have as much power as we need moving
- 24 forward.
- 25 So happy to answer any questions, but that's the

- 1 spirit and that's the lawful authority for it.
- 2 CHMN KATZ: Is there any other comment by
- 3 members of the Committee with respect to this matter?
- 4 Mr. Palmer.
- 5 MEMBER PALMER: You know, I would just interject
- 6 a thought here that if we were dragging the intervenor or
- 7 the applicant kicking and screaming into this condition,
- 8 then I would be inclined to agree with Member Grinnell.
- 9 But this is a condition that was agreed upon by
- 10 both the applicant and the intervenor to willingly do
- 11 this. So I don't know that we really have a lot of risk
- 12 or liability in putting this condition in there because
- 13 it's something that both parties asked for and agreed to.
- 14 CHMN KATZ: Again, from my perspective, I think
- 15 it is consistent with the statutory scheme. It's not, we
- 16 literally asked for, the one time we used it before was
- 17 when we had an existing applicant, an intervenor came in
- 18 saying they are wanting 650 million -- or \$65 million for
- 19 a ten-year easement.
- 20 And I can tell you my experience as a superior
- 21 court judge, knowing that that land was probably valued
- 22 at about \$10,000 an acre, and it wouldn't have interfered
- 23 with the project.
- We compelled good faith negotiations. And we
- 25 seldom are going to be asked to do it.

- 1 But in this case we're not compelling anybody to
- 2 do anything they don't want to do. There's a valid
- 3 stipulation on the record that was recorded by the court
- 4 reporter, and I don't have anything further to say.
- 5 Mr. Grinnell's position will be noted. And let
- 6 me just ask all in favor of this condition which has been
- 7 moved and seconded, please say aye.
- 8 (A chorus of "ayes.")
- 9 CHMN KATZ: Is there anybody other than Member
- 10 Grinnell that would say nay or no?
- 11 Mr. Grinnell, you are saying nay; correct?
- 12 MEMBER GRINNELL: Yes, sir.
- 13 CHMN KATZ: Thank you very much. That's noted
- 14 on the record.
- 15 Let's now go to our findings of fact and

CHMN KATZ: Condition 2 -- or finding 2 is 1 2 approved. Finding 3. 3 MEMBER HAMWAY: I move finding 3. 4 CHMN KATZ: Is there a second? MEMBER PALMER: Second. 6 CHMN KATZ: Any discussion? All in favor of 7 8 finding 3? 9 (A chorus of "ayes.") 10 CHMN KATZ: Anybody opposed? 11 (No response.) 12 CHMN KATZ: Number 4. 13 MEMBER GENTLES: I move 4. 14 MEMBER HAMWAY: Second. 15 CHMN KATZ: Any discussion? - 1 MEMBER HAMWAY: Second.
- 2 CHMN KATZ: Any discussion? All in favor?
- 3 (A chorus of "ayes.")
- 4 CHMN KATZ: Anybody opposed?
- 5 (No response.)
- 6 CHMN KATZ: The last thing we need to do with
- 7 respect to this is to go back to, I believe, it's on at
- 8 least in the original version was on page 2, lines 9
- 9 through 15. The line numbers may have changed.
- 10 But it just begins, "At the conclusion of the
- 11 hearing the Committee after considering the application,"
- 12 et cetera, and then we vote and it will be a roll call
- 13 vote.
- 14 MR. DERSTINE: Mr. Chairman?
- 15 CHMN KATZ: Yes.
- 16 MR. DERSTINE: Before you move on to that I
- 17 think we needed to clean up Condition 7.
- 18 CHMN KATZ: Oh, clean up Condition 7. Let's
- 19 take a look at condition second -- and then -- excuse me,
- 20 Condition 7. Read it with the new language in it and
- 21 then we'll need a motion to amend it.
- MR. DERSTINE: We haven't inserted anything in
- 23 it yet. Mr. Turner --
- 24 CHMN KATZ: Okay.
- 25 MR. DERSTINE: -- did you have --

- 1 MR. TURNER: Yep.
- 2 MR. DERSTINE: -- a minor edit?
- 3 MR. TURNER: Upon further inspection, I don't
- 4 think the language needs to change. And I'll state a few
- 5 things here.
- 6 Again, I'm looking at the CEC application, page
- 7 E18. And this is where the cultural summary is. We are
- 8 staying 150 feet away. The burials were 450 feet away.
- 9 So with this alignment, the conclusion was with
- 10 this alignment, SHPO recommendations and comments from
- 11 the Gila River Indian community would not be warranted.
- 12 So a monitor would not be needed unless this
- 13 alignment that we have talked about and looked at today
- 14 would change, such as the point of ownership change.
- 15 Then SRP would need to look at this boundaries for the
- 16 450 feet away and the 150 feet away.
- 17 So I don't know that the language needs to
- 18 change. I just want -- I appreciate everyone slowing
- 19 down and letting me look at this.
- 20 MR. DERSTINE: So if -- so the direction that we
- 21 received was if the line comes within, what's the
- 22 distance?
- 23 MR. TURNER: So right now the alignment that is
- 24 shown says that we are staying 150 feet away from the
- 25 boundary, the site boundary, and the closest human

- 1 features are 450 feet away.
- 2 So my concern would be if we changed the point
- 3 of change of ownership by 50 feet or 100 feet, or I don't
- 4 think we would be within these boundaries, but is there a
- 5 place for SRP to have to relook at this issue as they
- 6 maybe suggest some minor changes?
- 7 MEMBER LITTLE: Mr. Chairman.
- 8 CHMN KATZ: Yes, Member Little.
- 9 MEMBER LITTLE: I would really like to see
- 10 language in there that states that. Something along the
- 11 lines that should the alignment --
- 12 MEMBER HAMWAY: I think you could say something
- 13 like if the alignment shifts either way by X number of
- 14 feet. Something like that.
- 15 MEMBER LITTLE: Or how about if the alignment
- 16 shifts to within 150 feet of the identified site, or
- 17 something along those lines.
- 18 MR. DERSTINE: So this would be in addition just
- 19 putting at the end of Condition 7. So in the event,
- 20 comma, the alignment of the project shifts -- how do we
- 21 want to say this. Within --
- 22 CHMN KATZ: Maybe to within 150 feet of whatever
- 23 that -- whatever that cultural resource is. We have a
- 24 site number if you would like me to state that number.
- MR. DERSTINE: Is that -- can that be revealed

- 1 publicly? That's okay.
- 2 MR. TURNER: The site number.
- 3 MR. DERSTINE: Okay.
- 4 MEMBER HAMWAY: I don't think we need the site
- 5 number.
- 6 CHMN KATZ: I don't think we need the site
- 7 number. Let's keep that secret.
- 8 MR. TURNER: Okay.
- 9 MR. DERSTINE: Okay.
- 10 CHMN KATZ: Do we want to say of the identified
- 11 cultural resource?
- 12 MR. TURNER: I think that's fair. SHPO and the
- 13 tribes have looked at this in detail, and so I think the
- 14 generic language here would be acceptable. Cultural
- 15 resource?
- 16 MR. DERSTINE: Cultural resource. Then what, we
- 17 need further consultation or what's the --
- 18 MEMBER LITTLE: A site monitor needs to be
- 19 present; right?
- 20 MR. TURNER: Yes, ma'am. Thank you.
- 21 MR. DERSTINE: Okay.
- 22 CHMN KATZ: A site monitor would need to be
- 23 present; right?
- 24 MEMBER LITTLE: And we need the word "to," T-O,
- 25 between "shifts" and "within." "Shifts to within

- 1 150 feet."
- 2 CHMN KATZ: And I don't know under Robert's
- 3 Rules do we need to have a motion to just amend and then
- 4 approve to it as amended?
- 5 MEMBER HAMWAY: That's the safest way. I move
- 6 that we revote on 7 with the amendment as shown. Do you
- 7 want me to read it?
- 8 CHMN KATZ: Sure.
- 9 MEMBER HAMWAY: "In the event," my glasses
- 10 aren't very good.
- 11 CHMN KATZ: I can read it.
- 12 MEMBER HAMWAY: "In the event that the alignment
- 13 of the project shifts within 150 feet of the identified
- 14 cultural resource, a site manager would be" --
- 15 CHMN KATZ: Site monitor.
- 16 MEMBER HAMWAY: Okay.
- 17 -- "monitor would need to be present."
- 18 MEMBER PALMER: I would second the motion to
- 19 amend.
- 20 MEMBER GRINNELL: Question, Mr. Chairman.
- 21 CHMN KATZ: Yes, sir.
- 22 MEMBER GRINNELL: I understand this verbiage
- 23 here. But what action happens? In other words, where
- 24 does -- say they go to 100 feet of identified cultural
- 25 resources, what happens at that point?

- 1 MEMBER HAMWAY: A site manager has to be on
- 2 site.
- 3 MEMBER GRINNELL: But that doesn't provide --
- 4 that's -- doesn't provide an action.
- 5 MEMBER HAMWAY: Yeah, it does.
- 6 CHMN KATZ: The whole paragraph provides an
- 7 action, though. It has to get reported.
- 8 MR. DERSTINE: Correct, and with the --
- 9 MEMBER GRINNELL: With the --
- 10 MR. DERSTINE: -- the --
- 11 MEMBER GRINNELL: -- the preservation. But,
- 12 again, I understand what we're saying here. But does
- 13 this suspend the operation or the development --
- 14 MEMBER HAMWAY: Maybe.
- 15 MEMBER GRINNELL: -- until negotiations are met
- 16 between the identified parties in this section? What
- 17 happens to this?
- 18 CHMN KATZ: Or do we want it --
- 19 MEMBER GRINNELL: Yeah, I guess what happens if
- 20 this doesn't occur?
- 21 CHMN KATZ: It's the same as if any other
- 22 condition doesn't occur. Somebody has to enforce it.
- 23 But we could add, just I'll throw it out, where it says
- 24 resource -- identified cultural resource, a site monitor
- 25 would need to be present and the matter would need to be

- 1 reported to SHPO, or would it be the state museum?
- 2 MR. TURNER: This is Mark Turner. It would be
- 3 to SHPO and the site monitor is actually an
- 4 archaeologist, and they have the authority to stop work
- 5 if remains are found. And typically that's a temporary
- 6 half day while they sift through and figure out where
- 7 they are. But it could delay it for days until --
- 8 depending on what they find.
- 9 CHMN KATZ: Do we want to say a cultural
- 10 resource site monitor would need to be present after
- 11 reporting the issue to SHPO? I don't know if it's
- 12 necessary.
- 13 MR. TURNER: The monitor should be on site if
- 14 they're within 150 feet no matter if something is found
- 15 or not.
- 16 MR. DERSTINE: And Mr. Turner, is it defined
- 17 somewhere or explained somewhere what the
- 18 responsibilities of a site monitor are in that
- 19 circumstance?
- 20 MR. TURNER: It is not part of the CEC
- 21 application. Dr. Gene Rogge is the one who wrote this,
- 22 and I can reach out and coordinate with him today if we
- 23 need to be more specific.
- MR. DERSTINE: Well, no, I think we -- but I
- 25 think there is a general understanding of what the

- 1 responsibilities of a site monitor are in that
- 2 circumstance; correct?
- 3 MR. TURNER: Correct.
- 4 CHMN KATZ: We could go -- just another
- 5 suggestion. "In the event the alignment of the project
- 6 shifts to within 150 feet of the identified cultural
- 7 resource, SHPO shall be immediately notified and a site
- 8 monitor would need to be present." I don't know if we
- 9 need to go that far.
- 10 MR. TURNER: That language sounds good to me,
- 11 sir.
- 12 MEMBER HAMWAY: This is good.
- 13 CHMN KATZ: You think leave it as is?
- 14 MEMBER HAMWAY: Yes.
- 15 MEMBER PALMER: Yeah.
- 16 CHMN KATZ: Well, Member Little has moved to
- 17 leave it the way it is written, the amendment as written.
- 18 So it's been moved and seconded. Is there any further
- 19 discussion?
- 20 MEMBER MERCER: I have a question, Mr. Chairman.
- 21 My understanding is that this project is within an
- 22 existing project. So wouldn't any of this in Condition 7
- 23 be already covered? To me it sounds redundant.
- 24 CHMN KATZ: It is somewhat redundant because it
- 25 would have to be reported. But now we're saying based

- 1 upon the investigation of the archeological or cultural
- 2 resource study, that if it moves any -- it's at least
- 3 150 feet away right now -- if it moves any closer to that
- 4 by the applicant or its assignee, it would require that a
- 5 site monitor be present.
- 6 MEMBER HAMWAY: We approved a corridor of, what
- 7 was it, 1000 and then 1500 feet, I think.
- 8 MR. DERSTINE: Correct.
- 9 MEMBER HAMWAY: So we've got plenty of room for
- 10 them to maneuver around that, I would think.
- 11 CHMN KATZ: Any further discussion?
- 12 (No response.)
- 13 CHMN KATZ: All in favor to the amendment of 7,
- 14 please say aye.
- 15 (A chorus of "ayes.")
- 16 CHMN KATZ: Anybody opposed?
- 17 (No response.)
- 18 CHMN KATZ: The amendment passes. Do we need to
- 19 approve the whole condition as amended? I think -- I
- 20 think we're fine.
- 21 MEMBER HAMWAY: No, I think we did. We're fine.
- 22 CHMN KATZ: We're fine. Okay.
- Now we need to go back to the page 2 provision
- 24 which is our vote. And it just reads, "At the conclusion
- 25 of the hearing the Committee after considering the

- 1 application, evidence, testimony, and exhibits presented
- 2 by the applicant and comments of the public" -- and there
- 3 were no public comments -- "and being advised of legal
- 4 requirement" -- oh, there was one public comment --
- 5 "requirements of A.R.S. Sections 40-360 through 40-360.13
- 6 upon motion duly made and seconded, voted to, " and I'm
- 7 going to need to have a vote on a roll call basis as to
- 8 whether you, even if you've dissented on an individual
- 9 provision, you're free to vote in favor of the CEC.
- 10 And I'll start to my far left. And Member
- 11 Mercer, do you -- how do you vote, yea or nay?
- 12 MEMBER MERCER: Yea.
- 13 CHMN KATZ: Mr. Drago?
- 14 MEMBER DRAGO: Yea.
- 15 CHMN KATZ: Member Hamway?
- 16 MEMBER HAMWAY: Aye.
- 17 CHMN KATZ: Member Palmer?
- 18 MEMBER PALMER: Aye.
- 19 CHMN KATZ: And I'll next go to Member Little.
- 20 MEMBER LITTLE: I would like to thank the
- 21 applicant and everybody present in the room. And with
- 22 that I vote aye also.
- 23 CHMN KATZ: Member French?
- 24 MEMBER FRENCH: I vote aye.
- 25 CHMN KATZ: Member Gentles.

- 1 MEMBER GENTLES: I'd also like to thank the
- 2 applicants especially for their diligence in the public
- 3 outreach, even though this is a very short gen-tie line.
- 4 So they went through the diligence as if it were for a
- 5 larger project, so I do appreciate that. With that I
- 6 vote aye.
- 7 CHMN KATZ: Member Grinnell.
- 8 MEMBER GRINNELL: I vote aye.
- 9 CHMN KATZ: I believe that is nine to nothing.
- 10 If my arithmetic is correct.
- 11 MEMBER DRAGO: How do you vote?
- 12 CHMN KATZ: What?
- 13 MEMBER DRAGO: You vote?
- 14 CHMN KATZ: Oh, I'm voting also aye. So are
- 15 there nine of us or ten of us?
- 16 MEMBER HAMWAY: Just nine.
- 17 CHMN KATZ: There's nine. Okay. You'll fill in
- 18 nine to zero, and we're done with this particular CEC.
- 19 And, again, the --
- 20 MEMBER HAMWAY: You know what, it's nine.
- 21 CHMN KATZ: What?
- 22 MEMBER HAMWAY: It's nine, because Gabby's here.
- 23 I mean, it's 10 people.
- 24 CHMN KATZ: Yeah.
- 25 MEMBER HAMWAY: Yeah.

- 1 CHMN KATZ: Is that correct?
- 2 MEMBER HAMWAY: There's five of us and three --
- 3 four of them, so that makes nine.
- 4 MR. DERSTINE: Nine. Nine to zero.
- 5 CHMN KATZ: Nine to zero.
- 6 MEMBER HAMWAY: Nine to zero.
- 7 CHMN KATZ: Nine to zero. Correct. That ends
- 8 that. We're going to in a moment do CEC-2.
- 9 But what I'd like the applicant -- and the one
- 10 that we worked on will be Chair Exhibit 2. Chair
- 11 Exhibit 1 is the PDF version.
- 12 Now we're going to Chair Exhibit 3 will be the
- 13 PDF of CEC-2. And we'll be working off of Chair Exhibit
- 14 4, which is the Word version.
- And we can pull that up. What I'd like to do,
- 16 though, is we don't necessarily need to go through every
- 17 condition if they are the same as in the other one.
- 18 But I would need you to point out where there
- 19 are differences so that we can vote on those differences
- 20 and then approve the vote on the entire CEC.
- 21 MR. DERSTINE: Thank you, Mr. Chairman.
- There are no differences in the conditions
- 23 between CEC-1 and CEC-2.
- We need to make a conforming change to
- 25 Condition 7 of CEC-2 as we did in CEC-1. We can do that

- 1 or we can indicate that that will be done.
- 2 The only changes, differences between CEC-1 and
- 3 CEC-2, on CEC-2 lines 3 through 4 on page 3, at least
- 4 according to my paper copy, that is the -- right above
- 5 the Project Corridor and Route where the line says, "The
- 6 portion of the project covered by CEC-2 is approximately
- 7 0.11 mile in length from the point of change in PCO to
- 8 POI, point of interconnection."
- 9 That is different from CEC-1 because it
- 10 describes the segment of the line covered by CEC-2.
- 11 And then moving down under part C, Project
- 12 Corridor and Route, that is different from CEC-1 because
- 13 it describes the portion of the route covered by CEC-2.
- 14 That is the only difference between the two.
- Beyond that, all the conditions are the same.
- 16 As I indicated, we'll make the conforming change to
- 17 Condition 7.
- 18 CHMN KATZ: Let me then ask if we go to the
- 19 project overview, there's no need to change that except
- 20 the very last one-sentence paragraph; is that correct?
- 21 MR. DERSTINE: That's correct. There's no
- 22 change -- I mean, there is a change written there. I
- 23 just bring that to your attention that is a difference
- 24 between CEC-1 and CEC-2.
- 25 CHMN KATZ: Right. But paragraph or Section B,

- 1 Project Overview, remains the same except for that last
- 2 sentence within that project overview section; correct?
- 3 MR. DERSTINE: That is correct.
- 4 CHMN KATZ: So what I'd like to do is ask the
- 5 Committee to take a look at the language that says, "The
- 6 position of the project covered by CEC is approximately
- 7 0.11 mile in length from the PCO to the POI."
- 8 And I'd like to a motion to approve that
- 9 particular change to the project overview.
- 10 MEMBER PALMER: Mr. Chairman, just a question.
- 11 Would it be simpler just to approve the project overview
- 12 as written in --
- 13 CHMN KATZ: Yeah, we could do that.
- 14 MEMBER PALMER: And I'll make that motion.
- 15 MEMBER HAMWAY: Second.
- 16 CHMN KATZ: Okay. The motion again is to
- 17 approve Section B, the project overview as it is written
- 18 in Chair Exhibit 4. All in favor?
- 19 (A chorus of "ayes.")
- 20 CHMN KATZ: Anybody opposed?
- 21 (No response.)
- 22 CHMN KATZ: And, again, Condition 7 will be the
- 23 same with the additional language in it. So essentially
- 24 I think we just take a vote.
- 25 MEMBER HAMWAY: Well, we have to do Project

- 1 Corridor and Route.
- 2 CHMN KATZ: That's right.
- 3 MEMBER PALMER: And I would likewise move the
- 4 approval of item C, the Project Corridor and Route as
- 5 written.
- 6 MEMBER HAMWAY: Second.
- 7 CHMN KATZ: Any discussion? All in favor?
- 8 (A chorus of "ayes.")
- 9 CHMN KATZ: Anybody opposed?
- 10 (No response.)
- 11 CHMN KATZ: Now, we then go to the section that
- 12 requires us to vote once again to approve this CEC as
- 13 written. And we can do another roll call vote. And I'll
- 14 start with Member Mercer. How would you vote?
- 15 MEMBER MERCER: Aye.
- 16 CHMN KATZ: Member Drago?
- 17 MEMBER DRAGO: Vote aye.
- 18 CHMN KATZ: Member Hamway?
- 19 MEMBER HAMWAY: Aye.
- 20 CHMN KATZ: Member Palmer?
- 21 MEMBER PALMER: I vote aye, and I would like to
- 22 express my appreciation to the applicant, to the
- 23 intervenor, to the IT folks, the court reporter, all who
- 24 made this happen. And to the unnamed angel of mercy who
- 25 made the baklava, it was really good.

1 And with that, I vote aye. 2 CHMN KATZ: Member Little? 3 MEMBER LITTLE: Aye. CHMN KATZ: Member Gentles? 4 MEMBER GENTLES: I vote aye. CHMN KATZ: Member Grinnell? 6 MEMBER GRINNELL: Ave. 7 CHMN KATZ: And Member French? 8 9 MEMBER FRENCH: I vote aye. 10 CHMN KATZ: And I vote aye as well. 11 So we're looking, is it nine to nothing again? MEMBER HAMWAY: Yep. 12 CHMN KATZ: Okay. It is approved. I want to 13 14 thank everybody for the quality of the presentation. And 15 I agree with Member Gentles that public outreach went 16 above and beyond what might be minimally necessary. 17 There wasn't any opposition because of the --18 largely because of the location of the project not interfering with any existing industry, agriculture or 19 residential areas. 20 21 And I believe my only other comment is we dealt 22 with a project today that was approximately three-tenths 23 of a mile, maybe a little bit beyond that, and we have 24 nine Committee members participating in this, many of 25 whom are privately employed or have other community

- 1 involvement.
- 2 And later this afternoon, there will be a
- 3 special meeting of the Committee just to empower the
- 4 Committee to work with the legislature to try to shorten
- 5 the process for less lengthy -- for the less lengthy
- 6 projects so we don't necessarily need to have a hearing.
- 7 Or if we do need to have a hearing, it won't be
- 8 necessarily in front of the Committee. It could be in
- 9 front of an administrative law judge or a hearing
- 10 officer.
- 11 So any of you who want to join us at four this
- 12 afternoon, we will be having that meeting. I think it
- 13 will be relatively short.
- 14 And I also want to thank the AV and IT people
- 15 for making this a smooth operation as always and for
- 16 being willing to work us on as extremely short notice to
- 17 allow us to communicate during that special meeting this
- 18 afternoon.
- 19 In the future if we need to reconvene another
- 20 special meeting it will be much more than getting the
- 21 notice out on a Friday for a Tuesday meeting. And we
- 22 will have appropriate arrangements made. The Corporation
- 23 Commission will be reimbursing our court reporter for
- 24 that later hearing or meeting.
- 25 But anyway, we do stand in recess. Again, any

- 1 of you who want to join us this afternoon or in person or
- 2 virtually are welcome to do so. I would encourage all of
- 3 the Committee members, if at all possible, to be present.
- But, again, our sole focus will be on empowering
- 5 the Committee and its designee -- and the Chair's
- 6 designees to meet with the legislature representative,
- 7 Griffin, to try to draft some language to improve our
- 8 statutory scheme. We do stand in recess.
- 9 MEMBER PALMER: For clarification, that's going
- 10 to take place here?
- 11 CHMN KATZ: Yes, the meeting.
- 12 MEMBER PALMER: And on the link that was sent
- 13 out?
- 14 CHMN KATZ: Yes, there's a new link, some of you
- 15 should have received it either last week or early this
- 16 week from Tod for that Zoom meeting. If you're here in
- 17 person, we'll do it as normal, and if not it's not the
- 18 same link that we were using right now. Okay?
- 19 Any questions before we say goodbye and perhaps
- 20 again say it --
- 21 MEMBER GRINNELL: Mr. Chairman?
- 22 CHMN KATZ: Yes.
- 23 MEMBER GRINNELL: I just want to make a motion
- 24 to authorize yourself to make any scrivener's errors to
- 25 these applications.
