- 1 CHMN KATZ: We can go on the record.
- 2 This is the time for the prefiling conference in
- 3 the Orsted Eleven Mile Pinal County transmission line
- 4 project.
- 5 And Matt Derstine is present for the applicant.
- And is there anybody else that you wanted to
- 7 identify at this time?
- 8 MR. DERSTINE: Yeah. Thank you. Appearing
- 9 today also is Mark Turner with AECOM as well as Amy
- 10 Shanahan who's the project lead and project manager,
- 11 whatever titles that Amy collects of Orsted. And
- 12 Mr. Turner and Ms. Shanahan will be our primary
- 13 witnesses. Also, Kirsten Johnson from AECOM is also
- 14 here. And Ms. Odisho, who you'll recall from our last
- 15 APX hearing a couple of weeks ago, is also present, and
- 16 she'll be working with me on this case as well.
- 17 CHMN KATZ: Sounds good. Let me just ask you,
- 18 have there -- are there any possible intervenors in this
- 19 project? I haven't received anything, but --
- MR. DERSTINE: None that I'm aware of.
- 21 CHMN KATZ: And it's early. We don't have much
- 22 of anything going on yet. Has there been any public
- 23 interest generated from anything that has happened to
- 24 date?
- MR. DERSTINE: Well, Orsted is developing a

- 1 large solar project in the area. It's a 300-megawatt
- 2 solar project. And so this gen-tie project, a very short
- 3 gen-tie line, will allow the interconnection of the solar
- 4 project with the Pinal Central Substation. So there has
- 5 been interest in the solar project. I don't think we've
- 6 received a lot of interest in the siting of the gen-tie
- 7 line. As I mentioned, it's very short. But we have, you
- 8 know, had our outreach through newsletters and social
- 9 media as well as an in-person open house. So not a lot
- 10 of interest in the gen-tie and the issues that'll be
- 11 before the Committee.
- 12 CHMN KATZ: I'm just making a note. And I have
- 13 this saved, and I'll provide copies of that if I haven't
- 14 already. I have Prefiling Exhibit 1 which is just a map
- 15 of the project. Then I have Prefiling Exhibit 2 which is
- 16 your depiction of the actual route. I believe it's the
- 17 second map. Last, but not least, I have a Prefiling
- 18 Exhibit 3 which is a black-and-white legend showing where
- 19 signs have been posted to date.
- 20 Are these exhibits which you intended me to
- 21 receive and that you'll be providing copies of to our
- 22 reporter?
- 23 MR. DERSTINE: That's correct. Yes. And we're
- 24 happy to touch on those and run through those exhibits if
- 25 you like.

- 1 The Exhibit 1 primarily shows the project area,
- 2 where it's located, the gen-tie line in relation to Pinal
- 3 Central Substation and some of the -- as well as the
- 4 solar project which is shown kind of in the hashmarked
- 5 grid area.
- 6 So if there's value in that, Mr. Turner can
- 7 bring that up. And you have any questions about that,
- 8 and we're happy to address them.
- 9 CHMN KATZ: I don't have any questions. Both
- 10 maps appear clear. And that third map, black-and-white
- 11 diagram, shows where signs have been posted; correct?
- 12 MR. DERSTINE: That's correct.
- 13 CHMN KATZ: And you've published so far in
- 14 newspapers, or have you done any publishing yet?
- 15 MR. DERSTINE: Well, we haven't published -- we
- 16 haven't published yet --
- 17 CHMN KATZ: You don't have the notice yet.
- 18 Okay.
- 19 MR. DERSTINE: That's right. Yeah. But we
- 20 have --
- 21 CHMN KATZ: Where will you be publishing?
- 22 MR. DERSTINE: So I think what we're -- the
- 23 world of publication, we're left with the three local
- 24 newspapers that serve that area in Pinal County, the
- 25 Coolidge Examiner, the Enterprise, and the Casa Grande

- 1 Dispatch. And so we'll be publishing the notice of
- 2 hearing in all three of those. And probably one of
- 3 those, depending on their publication schedule, at least
- 4 getting two publications in in one of those. But among
- 5 the three, we'll certainly catch the two publications
- 6 within ten days.
- 7 CHMN KATZ: Okay. And I will need you to submit
- 8 in Word form a draft notice of hearing, and Tod and I
- 9 will review that. Send it to Tod with a copy to me, and
- 10 we'll review it. And if it appears to be in proper
- 11 order, which I'm sure it will be based upon the high
- 12 level of experience that you and your staff have had, I
- 13 will sign it and we'll get it back to you in a PDF
- 14 format.
- 15 MR. DERSTINE: All right. Thank you.
- 16 CHMN KATZ: And -- what?
- 17 MR. DERSTINE: I was going to say I think we're
- 18 scheduled for filing on December 2. I want to -- we need
- 19 to do a little bit of confirmation. As you know,
- 20 sometimes the publication schedules of these newspapers
- 21 make it difficult for us to get the two publications in
- 22 timely. So we're just going to, at the moment,
- 23 confirming the publication schedule and how early they
- 24 need the notice of hearing signed by you in advance of
- 25 publication. Once we've pinned that down, we'll confirm

- 1 with Tod that July 2 is -- December 2 is indeed our
- 2 publication date. And we'll be sending you the draft
- 3 notice of hearing this week.
- 4 CHMN KATZ: Okay. I'm here all week. And next
- 5 week, though, I will be in another line siting hearing
- 6 out in Goodyear.
- 7 MR. DERSTINE: Okay.
- 8 CHMN KATZ: Who are the affected jurisdictions?
- 9 MR. DERSTINE: So they are the City of Coolidge,
- 10 the City of Eloy, and Pinal County.
- 11 CHMN KATZ: Okay. And they'll all receive
- 12 notice if they haven't already; correct?
- 13 MR. DERSTINE: They will.
- 14 CHMN KATZ: And where will the -- I know it's in
- 15 Pinal County, but where will the hearing be taking place?
- 16 MR. DERSTINE: The hearing will be conducted at
- 17 the Radisson Hotel Casa Grande on 777 North Pinal Avenue.
- 18 CHMN KATZ: Okay. Is that the same hotel that
- 19 we've been in previously, or not?
- MR. DERSTINE: I think so.
- 21 CHMN KATZ: Okay. And the dates for the
- 22 hearing, when do we begin? January what?
- 23 MR. DERSTINE: We're scheduled to begin on
- 24 January 17, which is a Tuesday as opposed to a Monday
- 25 start.

- 1 CHMN KATZ: It's a holiday?
- 2 MR. DERSTINE: I think it's Martin Luther King
- 3 Day, Chairman, yeah.
- 4 CHMN KATZ: Okay. I'm assuming we should be
- 5 done by Thursday?
- 6 MR. DERSTINE: Yes, if not sooner.
- 7 CHMN KATZ: And I'm assuming that there will be
- 8 lodging available at that hotel for staff and for our
- 9 out-of-town Committee members. And I don't know if we're
- 10 making our own reservations or whether the applicant will
- 11 make those for us, but you can let -- somebody will need
- 12 to let Tod know and let me know because we need to let
- 13 the Committee members who might be traveling know as
- 14 well. I can't see commuting back and forth between my
- 15 home in the Phoenix metro area and -- as you know.
- 16 Do you think we need a tour? How long is this
- 17 line?
- 18 MR. DERSTINE: Very short. It's three-tenths of
- 19 a mile in length. Very short. You've been down in that
- 20 area before. But, you know, we have reserved a van and
- 21 transportation and looked at conducting a tour. I'm not
- 22 sure that a tour would take very long, but I don't know
- 23 how much information the Committee would glean from the
- 24 route tour as opposed to the virtual tour that we'll
- 25 present to the Committee on the first day of the hearing.

- 1 CHMN KATZ: I'll leave it to the Committee, but
- 2 I'll probably be -- this doesn't run adjacent to or
- 3 through any residential communities, does it?
- 4 MR. DERSTINE: It does not. It crosses a road
- 5 and then a number of existing power lines and then drops
- 6 into Pinal Central Substation. And a portion of this
- 7 gen-tie line is underground already. So the aboveground
- 8 portions are largely on the side of the Pinal Central
- 9 Substation where there's already an existing transmission
- 10 corridor.
- 11 And Mr. Turner is showing you the route. The
- 12 dotted red area is what is going to travel underground
- 13 from the project substation shown in the purple square.
- 14 And then that first structure is outlined there in terms
- 15 of the riser structure where the underground line comes
- 16 aboveground. And then we move on to the red structure
- 17 that's the second structure there. That's the point of
- 18 change of ownership, something that the Committee's heard
- 19 and is familiar with. That's where from that point on,
- 20 we'll -- there will be -- as we have done in prior cases,
- 21 there'll be two CECs, and we'll transfer the second CEC
- 22 to SRP. They'll own that piece. And then the blue
- 23 portion is the aboveground portion, remaining aboveground
- 24 portion, of the gen-tie that moves to the Pinal Central
- 25 Substation and interconnects with the bay there.

- 1 CHMN KATZ: And that was your prefiling
- 2 Exhibit 2?
- 3 MR. DERSTINE: Correct.
- 4 CHMN KATZ: I can't see the need based upon the
- 5 how short the aboveground section is -- basically, it's
- 6 running from pretty much raw desert into an already
- 7 existing substation. I don't think a tour will be
- 8 necessary. If we did want to take one, we'd probably
- 9 want to do it about nine o'clock or so on Wednesday
- 10 morning because we're starting --
- 11 MR. DERSTINE: Yeah. Since we're starting on
- 12 Tuesday? Yeah, we would start it first --
- 13 CHMN KATZ: -- one o'clock on Tuesday. 5:30
- 14 public comment session. And it could be like a couple of
- 15 recent hearings where we had to wait two or three hours
- 16 for nobody to appear, but we'll do whatever we have to do
- 17 to make sure that the public is given a fair opportunity
- 18 to participate.
- 19 When will we be holding our prehearing
- 20 conference?
- 21 MR. BREWER: Mr. Chairman, we have this
- 22 scheduled for January 9 at three p.m.
- 23 CHMN KATZ: Does that work for the applicant?
- 24 MR. DERSTINE: Yes. I think we've had that on
- 25 our calendar, and that works for --

- 1 CHMN KATZ: Right. And we don't have any
- 2 outside related litigation to worry about. And we need
- 3 to make sure that all of our Committee people get a copy
- 4 of the application.
- 5 One of the things we're trying to iron out, and
- 6 I don't know that we've made any progress, is a lot of
- 7 the complicated -- more complicated -- we end up with 25
- 8 copies of everything that the corporation sent certified
- 9 mail, and some of the Committee members are getting
- 10 frustrated with ending up with two or three boxes full of
- 11 documents.
- 12 MR. DERSTINE: Yeah.
- 13 CHMN KATZ: We just need to make sure they get
- 14 copies of the application.
- 15 What do you think, Tod, do we need to send hard
- 16 copies over for the docket and they distribute it?
- 17 MR. BREWER: Docket will distribute that,
- 18 Mr. Chairman.
- 19 CHMN KATZ: And we haven't looked up anything
- 20 about eliminating some of the paperwork like exhibits and
- 21 things of that nature?
- MR. BREWER: No, Mr. Chairman, we have not.
- 23 CHMN KATZ: And I will also work with Tod to
- 24 draft a Procedural Order. It's pretty much going to be a
- 25 copy of what we do in almost every case setting out

- 1 various deadlines for exchanging exhibits and witness --
- 2 filing witness statements, et cetera.
- 3 And we'll need -- there's two CECs. I'm
- 4 assuming they'll be substantially identical?
- 5 MR. DERSTINE: That's correct.
- 6 CHMN KATZ: And what we have done in the past in
- 7 our last hearing, we reviewed each and every paragraph of
- 8 the first CEC. And the second CEC was identical except
- 9 for the property description or the project description.
- 10 And we just ended up with an avow being made that they're
- 11 identical except for paragraph 7, 12, or whatever it
- 12 might be, and the project description. We will vote --
- 13 we will just vote on approving that second CEC if we
- 14 approve the first one. We're not going to go through
- 15 every condition a second time and every finding. We'll
- 16 just go through the conditions or findings that are
- 17 applicable to the second CEC.
- 18 MR. DERSTINE: Understood.
- 19 CHMN KATZ: Okay. We've already decided that
- 20 that -- we've talked about trying to move that public
- 21 hearing -- public participation to a different time, but
- 22 we want to accommodate people that have to work --
- MR. DERSTINE: Right.
- 24 CHMN KATZ: -- so it will be 5:30 Wednesday.
- 25 And if any public officials wish to address us

- 1 at the public comment session, they'll be given priority
- 2 over members of the general public to speak first.
- 3 I'm assuming that you -- your client has applied
- 4 for and/or received all necessary federal, state, county,
- 5 city, or town permits and that we don't have any
- 6 hang-ups? And I'm assuming that there is no federal
- 7 funding involved and no federal property involved so we
- 8 don't have to worry about NEPA?
- 9 MR. DERSTINE: That's correct. No NEPA issues.
- 10 And any permits that are required at this stage have been
- 11 applied for and have been obtained. There'll be permits
- 12 that are required down the road once we get closer to the
- 13 construction stage, et cetera.
- 14 CHMN KATZ: And I'm assuming we'll have our
- 15 usual -- one of our two usual groups of IT people so that
- 16 we'll have good Wi-Fi hotspots.
- 17 And I didn't know if you were going to be
- 18 providing any type of Surface Pros or iPads to us.
- 19 Because outside of the fact I always want one copy of the
- 20 exhibits like in a notebook or somehow bound and the
- 21 application, most of the Committee members are happy to
- 22 view the exhibits on iPads or a Surface Pro or some
- 23 similar tablet.
- MR. DERSTINE: Yes.
- 25 CHMN KATZ: You can bring a couple of extra

- 1 copies of the exhibits. I'm assuming we'll have tablets?
- 2 MR. DERSTINE: That's correct. We'll be
- 3 providing iPads. Peak Audio will be providing the AV
- 4 service. And we'll make sure that you have your hard
- 5 copy of exhibits as well as the application.
- 6 CHMN KATZ: And I always remind you, you already
- 7 know that the court reporting company always likes final
- 8 transcripts of conferences and hearings to be posted on
- 9 the applicant's website. And, obviously, there's a
- 10 turnaround time of about three days to obtain those
- 11 transcripts.
- 12 MR. DERSTINE: Yeah. And I was going to -- I
- 13 know your Procedural Order requires we get those
- 14 posted -- I don't know if it's three or five days. Tod,
- 15 you probably know. But sometimes that's -- it's not the
- 16 court reporter's turnaround time. It's the time it takes
- 17 for the IT folks to get them posted to the website that
- 18 sometimes makes that time frame a challenge. But we
- 19 always do our best to get them posted to the website as
- 20 quickly as possible.
- 21 CHMN KATZ: As long as they get posted. If
- 22 you're a day or an hour late, we're not going to come
- 23 down on you. We just want to make sure that the public
- 24 has access to know what the heck we talked about.
- 25 MR. DERSTINE: Right.

- 1 CHMN KATZ: And the Committee members also have
- 2 the right to know what we've discussed.
- 3 I'm assuming that there are no other issues for
- 4 us to cover. If there are, please enlighten me.
- 5 MR. DERSTINE: I think that's it. I don't know
- 6 if you wanted to take a look at the proposed sign
- 7 locations. That's our Prefiling Exhibit 3, and if you
- 8 had any concerns with that?
- 9 CHMN KATZ: I don't have any concerns. It looks
- 10 like they're posted along public roads. And it's really
- 11 that one road that is where the line crosses. So I think
- 12 we're in good shape. And we'll make sure that that
- 13 Exhibit 3 showing the sign posting locations are also
- 14 provided to our court reporter.
- 15 MR. DERSTINE: That's correct. I think -- if we
- 16 haven't provided all three exhibits to our court
- 17 reporter, we'll make sure that she receives them this
- 18 afternoon.
- 19 CHMN KATZ: And, Tod, is there anything else
- 20 that I may have forgotten to cover that you think we need
- 21 to discuss?
- MR. BREWER: I don't believe so. Thank you,
- 23 Mr. Chairman.
- 24 CHMN KATZ: And you're going to be still stuck
- 25 with me. I was hoping to have my replacement at least

- 1 attending the November and December hearing. But they
- 2 can't appoint anybody because it's the attorney general,
- 3 and we don't know who the attorney general's going to be.
- 4 And Don Northup, who basically is a supervisor of
- 5 supervisors in civil matters, is also going to retire at
- 6 the end of the year. I was trying for January 28, but I
- 7 was hoping to have somebody trained by beginning of
- 8 January or the beginning of February so I could spend my
- 9 last week or two wrapping up everything for the land
- 10 department and mine inspector. But it's becoming -- the
- 11 line siting is becoming a major time consumer for
- 12 everyone. There are different opinions, but I'm
- 13 encouraging lawyers such as yourself, and I know we're
- 14 talking Member Hamway and others, but I think we need a
- 15 comprehensive statutory change, and it's not going to
- 16 happen unless we have industry and the lawyers working
- 17 with members of the legislature. Because I've already
- 18 met with the chair, and so has Mary Hamway twice, but I
- 19 met once with the chair of the Corporation Commission.
- 20 And, well, I'll give you -- it's too political or we're
- 21 too busy. They're not going to do anything. And I think
- 22 for us to have to have a hearing for a three-tenths of a
- 23 mile -- I've had a 750-foot line and a 440-foot that we
- 24 had to have full-blown hearings on. And it just seems to
- 25 me that an administrative law judge or a hearing offer

- 1 could make the decision and it maybe could even be done
- 2 on written application. I just don't know what the
- 3 answer is. But the drafters of that 1970 statute had no
- 4 idea that we'd be looking an unregulated solar and wind
- 5 industry, which is fine, but we don't know where these
- 6 projects are going to be built and whether they're in the
- 7 best places. But there is control over the major
- 8 utilities that the Corporation Commission can say, "You
- 9 can't build that generation in Pinal County. You have to
- 10 build it in Cochise County. Whatever." I'm not unhappy.
- 11 It's just to have to have hearings for gen-tie lines that
- 12 oftentimes are running through agricultural or vacant
- 13 desert is an awful great expense to the applicant and a
- 14 big investment of time to me and the Committee members,
- 15 most of whom have outside interests and/or employment.
- 16 Enough said. If I don't see any of you between
- 17 now and then, have a Merry Christmas -- yes, Jennifer?
- 18 (Discussion off the stenographic record;
- 19 technical issues.)
- 20 THE COURT REPORTER: We can do this on or off
- 21 the record. But I need to know everyone's names and
- 22 titles, please.
- 23 MR. DERSTINE: Let's do it on the record. Mark,
- 24 what's your --
