Next Steps

- 1. Environmental studies will continue for the study area.
- 2. In order to gather detailed data around wind speed and direction, a Meteorological Mast (met mast) is proposed for erection.
- 3. A dedicated Environmental Impact Assessment consultant will be appointed.
- 4. Community engagement will continue in the locality sharing information and listening to gueries and concerns.


