Your opportunity to feedback on our proposed offshore wind farm

This document contains details of our proposals, our upcoming events and how to take part in this consultation.

Orsted Hornsea Project Four Offshore wind farm Ltd are proposing to develop a new offshore wind farm (Hornsea Four) located approximately 65 km off the East Riding of Yorkshire coast which will connect into Creyke Beck National Grid Substation, just north of Cottingham.

Your feedback is important

This formal consultation is another opportunity for you to influence our proposal. All the feedback received during this consultation period will be considered by the Project and will help to shape the final design that we submit to the Planning Inspectorate in Q1 2020 and will be summarised in the accompanying Consultation Report.

This consultation

Public consultation for Hornsea Project Four commenced in September 2018 and consultation will continue up to the point of consent application submission in 2020. To develop our proposal, we have considered the outputs from;

- Ongoing discussions with the local authorities, specialist groups, local representatives and community groups;
- Feedback gathered at our community consultation events (Autumn 2018);
- Findings from environmental, technical and feasibility studies.

In this consultation (13 August 2019 to 23 September 2019), we are asking you to comment on the findings of initial surveys and assessments (detailed in our Preliminary Environmental Information Report (PEIR)) and for you to let us know your thoughts on the proposed Project. Detail of the proposed Project and PEIR will also be shown at the September Community Consultation events. This is your opportunity to let us know what you think and make us aware of any other factors we need to consider as we shape the final design that we submit to the Planning Inspectorate in 2020.

Please note that certain survey work is <u>ongoing</u> and will continue to feed in our refinement process along with the results of this round of consultation.

What are we asking you to comment on?

We would like you to tell us your thoughts on our proposed development, including where we intend to build it, how we intend to build it and how we are proposing to reduce any potential environmental effects where this can currently be identified.

This includes your thoughts on;

- Overall project proposal;
- Offshore array area located approximately 65 km from the coast, (where the offshore wind turbines, array and interconnector cables, offshore substation/s and offshore accommodation platforms will be situated);
- Offshore export cable corridor, extending approximately 1.5 km in width for approximately 100 km in length) between the array area and landfall, (where the export cables will be laid/buried);
- The proposed offshore HVAC booster stations
- Landfall zone located near Fraisthorpe, (where the export cables are brought ashore);
- Onshore cable corridor search area currently 80 m in width and approximately 40 km in length (where the export cables will be buried from the landfall routed via the onshore substation/s and connected finally to National Grid's Creyke Beck substation):
- The proposed onshore substation (HVAC substation/HVDC convertor station) near Creyke Beck substation); and
- The areas identified for temporary logistics compounds and potential permanent and temporary access routes.
