#### **Abnormal Load Movements**

As part of our work to prepare for the installation of the Hornsea Three onshore cable, we are required to transport equipment and materials to and from our compound in Oulton. Due to the nature of our works, some of these deliveries require larger specialised vehicles called abnormal loads.

We wish to inform you of the planned abnormal load movements from our Oulton compound to the northern section of our cable route only, which are planned to pass through or near your area.

Please find overleaf three sets of schedules for our inbound and outbound abnormal load deliveries. Maps indicating their routes can also be found overleaf. The outbound abnormal loads are from our compound in Oulton to our cable route. The inbound abnormal loads pass through Holt to our compound in Oulton. We have also included additional abnormal load movements where we are required to transport machinery between sites on our cable route. These additional movements will follow the along the same routes as the outbound abnormal loads.

Unless otherwise indicated, to minimise disruption and ensure safety, we expect these abnormal load movements will be escorted by police vehicles and undertaken during off-peak hours, **Monday – Friday** between **9am and 3pm.** 

# Please note that all our works are subject to site and weather conditions and our deliveries are dependent on agreements with Norfolk County Council and Norfolk Constabulary and are subject to change.




#### **Outbound and Additional Movements Map**
