Background 1.1




Figure 2.1: Aggregate and disposal projects, plans and activities in the Southern North Sea.









Figure 2.2: Offshore energy projects, plans and activities in the southern North Sea.











Figure 2.3: Oil and gas projects, plans and activities in the southern North Sea.











Figure 2.4: Cables and pipeline projects, plans and activities in the southern North Sea.











Figure 2.5: Shipping and navigation projects, plans and activities in the southern North Sea.








Figure 2.6: Aviation projects, plans and activities in the southern North Sea.










Figure 2.7: Radar projects, plans and activities in the southern North Sea.








Figure 2.8: Coastal projects, plans and activities in the southern North Sea.





Figure 3.1: Onshore projects, plans and activities (figure 1 of 5).


















Figure 3.3: Onshore projects, plans and activities (figure 3 of 5).










Figure 3.4: Onshore projects, plans and activities (figure 4 of 5).










Figure 3.5: Onshore projects, plans and activities (figure 5 of 5).
