

AUGUST 2021**NOTICE OF PUBLIC COMMENT HEARING**

TO ALL OWNERS AND RENTERS OF PROPERTY ALONG THE ROUTE OR POTENTIAL ROUTE OF UNDERGROUND ELECTRIC TRANSMISSION CABLES AND/OR LOCATION OF THE INTERCONNECTION FACILITIES (ADJACENT TO THE EXISTING DAVISVILLE SUBSTATION) FOR THE REVOLUTION WIND PROJECT (THE "PROJECT"), A PUBLIC HEARING IS BEING CONDUCTED, AS REQUIRED BY R.I. GEN. LAWS § 42-98 AND § 42-35, AS AMENDED, IN PARTICULAR § 42-98-9.1(b) AND RULE 1.8(g) OF THE ENERGY FACILITY SITING BOARD'S (THE "BOARD") RULES OF PRACTICE AND PROCEDURE, FOR THE BOARD'S CONSIDERATION OF WHETHER TO ISSUE A LICENSE FOR REVOLUTION WIND, LLC TO SITE AND CONSTRUCT THE PORTIONS OF THE PROJECT WITHIN ITS JURISDICTION.

PLEASE TAKE NOTICE THAT, on Wednesday, September 22nd, 2021, at 6:00 p.m. a public hearing will be conducted by the Energy Facility Siting Board (the "Board") to receive public comment on the Application of Revolution Wind, LLC to site and construct the facilities associated with the Revolution Wind Project (the "Project"), which Revolution Wind, LLC filed with the Board on December 30th, 2020. The Project is an offshore wind farm that is projected to deliver approximately 704 MW of renewable energy to Rhode Island and Connecticut.

The purpose of this hearing is to provide the public with the opportunity to comment on the proposed siting and construction of the facilities associated with the Project specifically within the State of Rhode Island. Those are: (1) an onshore transmission cable consisting of two one-mile underground transmission lines between the Quonset Business Park landing location and the new onshore substation; (2) a 23-mile submarine export cable running from federal waters to the onshore transmission cable; (3) an onshore substation located proximate to the existing Davisville substation in Quonset; (4) expansion of the Davisville substation; (5) two new 519-foot underground transmission lines between the onshore substation and the expanded Davisville substation; and (6) reconfiguration of 1,340 feet of existing overhead transmission lines looped into the Davisville substation.

Your property has been identified as abutting or adjacent to a portion of the Project's known or potential route. Per Board requirements, you are being provided with this notice to inform you

about the Project and provide you with information on how to participate in the upcoming Public Hearing.

Note that the Board is not considering the siting and construction of the offshore wind turbines or offshore substation associated with the Project because they are located in federal waters outside of the Board's jurisdiction. The application is on file and available for public review at the Board office located within the Public Utilities Commission office building at 89 Jefferson Boulevard, Warwick, Rhode Island.
