RE: Case 20-T-0617: Application of Sunrise Wind LLC for a Certificate of Environmental Compatibility and Public Need for the Construction of Up to 6.2 Miles (320 kilovolt [kV]) of Direct Current (DC) Submarine Export Cable from the New York State Territorial Waters Boundary to the Smith Point County Park on Fire Island in the Town of Brookhaven in Suffolk County and Up to 17.5 Miles (320 kV) of Onshore Transmission Cable from the Landfall at Fire Island to a New Onshore Converter Station in the Town of Brookhaven and Up to 1 Mile (138 kV) of Alternating Current (AC) Onshore Interconnection Cable Connecting to the Existing Holbrook Substation in the Town of Brookhaven in Suffolk County

Dear Secretary Phillips:

On behalf of Sunrise Wind LLC (Sunrise Wind), enclosed for filing in the above-referenced proceeding please find a redacted version of Sunrise Wind's Phase 2 Environmental Management & Construction Plan (the Phase 2 EM&CP) for the Sunrise Wind New York Cable Project (the Project). In addition to the narrative, the Phase 2 EM&CP includes the following appendices applicable only to Phase 2 work on the Project:

In accordance with Certificate Condition 37 of the Project's Certificate of Environmental Compatibility and Public Need (CECPN), Sunrise Wind will, contemporaneously with this filing, provide copies of the Phase 2 EM&CP as follows: (1) three hard copies and one electronic copy to your office; (2) an electronic copy to: the Commissioner of Parks, Recreation and Historic Preservation, the Commissioner of the Department of Transportation, the General Counsel of the Long Island Power Authority, the Secretary of State of the Department of State, the Commissioner of the Department of Agriculture and Markets, and the Commissioner of the Department of Environmental Conservation (NYSDEC); (3) one hard copy and one electronic copy to the NYSDEC's Central Office; (4) one electronic copy to all parties in this proceeding; and (5) hard copies for inspection at the Brookhaven Free Library, the Mastics-Moriches-Shirley Public Library, and the Sachem Public Library.² Consistent with CECPN Condition 40, Sunrise Wind will file the supporting affidavits of service by March 30, 2023.

Further, pursuant to CECPN Conditions 37 and 38, notice of the Phase 2 EM&CP filing (the Filing Notice) will be served on all parties to this proceeding and owners of property crossed by or abutting the impacted portion of the Project corridor. Finally, Sunrise Wind has published the Filing Notice in the following newspapers of general circulation along the Project corridor: South Shore Press, South Bay's Neighbor Newspapers, Long Island Advance, The Suffolk Times, and Village Beacon Record. Consistent with CECPN Condition 40, Sunrise Wind will file the supporting affidavits of service by March 30, 2023 and publication when they become available.

¹ A request for protection of the confidential information contained in Appendix RR is enclosed for filing and will be contemporaneously provided under separate cover to the New York State Public Service Commission's (Commission) Record Access Officer.

² Upon request, Sunrise Wind will provide any party to this proceeding or other New York State agency with a USB flash drive containing the Phase 2 EM&CP.
