

## Notice of Commencement of Additional Construction Case 20-T-0617

Sunrise Wind LLC (SRW) anticipates commencing construction of certain portions of its Sunrise Wind Cable Project (Project) on or after **September 15, 2023**.

### Phase I Project Description

This first phase includes several categories of the Project's onshore work. In the coming weeks, SRW will commence work on certain portions of that work, referred to herein as Phase 1B work. The installation of civil works (e.g., splice vaults and duct banks) along certain New York State Department of Transportation-controlled rights-of-way and necessary expansion work at the existing Holbrook Substation. All of this work will occur in the Town of Brookhaven (the Town).

### Overall Project Description

New York State Public Service Commission (PSC) issued a Certificate of Environmental Compatibility and Public Need (CECPN) to SRW to construct and operate the Project, which is a 5.2-mile 320 kV DC submarine export cable from the New York State territorial waters boundary to the Smith Point County Park on Fire Island in the Town; 17.5-miles of 320 kV DC onshore, underground transmission cable to a new Onshore Converter Station in the Town; and 1.1 miles of 138 kV AC interconnection cable that will allow interconnection with the existing electric grid. The Project will transmit electricity produced by the Sunrise Wind Farm, to be located in federal waters approximately 30 miles off the east coast of Long Island, to the existing Holbrook Substation.

The Project's Environmental Management and Construction Plan (EM&CP) has been filed with the PSC and can be viewed on SRW's website ([www.sunrisewindny.com](http://www.sunrisewindny.com)) and on the PSC's website, ([www.dps.ny.gov](http://www.dps.ny.gov)).

### Construction Timeline

Construction of Phase 1B work is expected to begin on or after 9/15/2023. The Project is estimated to be completed by the end of 2025. A separate notice will be sent to neighboring landowners and municipalities prior to subsequent Project work.

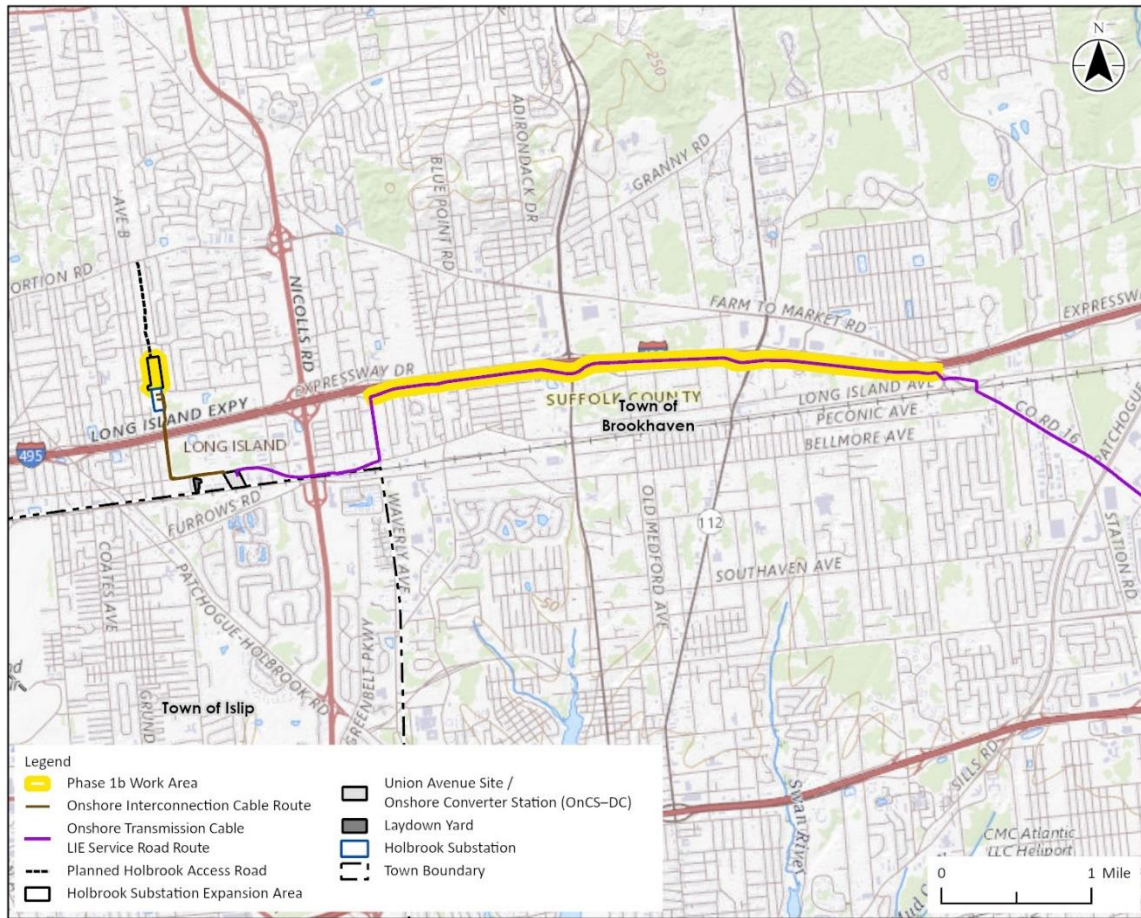
